2. Consideration

The offering that is the subject of this Agreement shall be for the exclusive benefit of Alameda County Water District. Ohlone College shall not receive any State support for these services. In consideration for related services provided by Ohlone College, Alameda County Water District agrees to pay **\$1,800** as determined below:

2 4-hour sessions.....\$1,800

3. Cancellation

- 3.1 Ohlone College retains the right to cancel the services offered under this Agreement within 14 days of the start of the project. If Ohlone College cancels these services, ACWD shall not be liable for any payments to Ohlone College.
- 3.2 ACWD retains the right to cancel services offered under this Agreement no later than 14 days before the start of the project.

4. Additional Terms

Alameda County Water District agrees not to contract independently with the Entrepreneurial Programs trainer(s) for a period of one year after the completion of the training.
