2. Consideration

The offering that is the subject of this Agreement shall be for the exclusive benefit of NUMMI and shall be open to its designees only. Ohlone College shall not receive any State support for the classes. In consideration for the instructional and related services provided by Ohlone College, NUMMI agrees to pay **\$21,800.00** as determined below:

- 2.1 Instruction, 144 hours @ \$150/hour.....\$21,600.00  
( 72 hours per course)
- 2.2 Intermediate Algebra Math Assessment

3. Cancellation

- 3.1 Ohlone College retains the right to cancel a course offered under this Agreement no later than 7 days before the first meeting of the course. If Ohlone College cancels a course, NUMMI shall not be liable for any payments to Ohlone College.
- 3.2 NUMMI retains the right to cancel a course offered under this Agreement no later than 7 days before the first meeting of the course.

4. Additional Terms

- 4.1 NUMMI agrees not to contract independently with the Workforce Development trainer(s) for a period of one year after the completion of the training.
