2. Consideration

The offering that is the subject of this Agreement shall be for the exclusive benefit of Muir Senior Care and shall be open to its designees only. Ohlone College shall not receive any State support for the classes. In consideration for the instructional and related services provided by Ohlone College, Muir Senior Care agrees to pay **\$1100** as determined below:

- 2.1 One two hour session @ \$1100/session.....\$1,100

3. Cancellation

- 3.1 Ohlone College retains the right to cancel a course offered under this Agreement no later than 7 days before the first meeting of the course. If Ohlone College cancels a course, Muir Senior Care shall not be liable for any payments to Ohlone College.
- 3.2 Muir Senior Care retains the right to cancel a course offered under this Agreement no later than 7 days before the first meeting of the course.

4. Additional Terms

Muir Senior Care agrees not to contract independently with the Entrepreneurial Programs trainer(s) for a period of two years after the completion of the training.
