2. Consideration

The offering that is the subject of this Agreement shall be for the exclusive benefit of ABAG Plan Corporation and shall be open to its designees only. Ohlone College shall not receive any State support for the classes. In consideration for the instructional and related services provided by Ohlone College, ABAG Plan Corporation agrees to pay **\$3,300.00** as determined below:

- 2.1 Two 3 hour sessions @ \$1,200/session.....\$2,400.00
- 2.2 One 4 hour session @ \$900.00/session 900.00

3. Cancellation

- 3.1 Ohlone College retains the right to cancel a course offered under this Agreement no later than 7 days before the first meeting of the course. If Ohlone College cancels a course, ABAG Plan Corporation shall not be liable for any payments to Ohlone College.
- 3.2 ABAG Plan Corporation retains the right to cancel a course offered under this Agreement no later than 7 days before the first meeting of the course.

4. Additional Terms

ABAG Plan Corporation agrees not to contract independently with the Entrepreneurial Programs trainer(s) for a period of two years after the completion of the training.
