

## BP 2010 Board Membership

Reference: **Education Code Sections 72023, 72103; 72104**

Board Approved: 04/13/05

The Board shall consist of seven members elected by the qualified voters of the District. Members shall be elected at large as defined in Board Policy 2100.

Any person who meets the criteria contained in law is eligible to be elected or appointed a member of the Board.

An employee of the District may not be sworn into office as an elected or appointed member of the governing board unless he or she resigns as an employee.

No member of the governing board shall, during the term for which he or she is elected, hold an incompatible office.

## BP 2010 Board Membership

**Education Code Sections 72023, 72103; 72104**

The Board shall consist of [ # ] members elected by the qualified voters of the District. Members shall be elected [ *at large or by trustee area as defined in Board Policy 2100* ].

Any person who meets the criteria contained in law is eligible to be elected or appointed a member of the Board.

An employee of the district may not be sworn into office as an elected or appointed member of the governing board unless he or she resigns as an employee.

No member of the governing board shall, during the term for which he or she is elected, hold an incompatible office.

## BP 2105 Election of Student Member(s)

Reference: Education Code Sections 72023.5, 72103

Board Approved: 04/13/05

The student member of the Board of Trustees shall be chosen by the students enrolled in the District as follows:

The student member shall be elected by all the students of the student body in a general election held for that purpose. Normally an election will be held in the month of April so that the office is filled by ~~July 1~~ June 1.

Special elections shall be held if the office becomes vacant by reason of the resignation or disqualification of an elected student member, or by any other reasons. Special elections shall be held within thirty days after notice of the vacancy comes to the attention of the President/Superintendent.

Candidates for the position may nominate themselves or be nominated by others by the filing of an application certifying that the candidate is eligible for service under the criteria set forth in California law and these policies. The election shall be conducted in accordance with administrative procedures established by the President/Superintendent

## BP 2105 Election of Student Members

Reference:

**Education Code Sections 72023.5, 72103**

The student member[s] shall be chosen by the students enrolled in the district as follows:

**Note: Boards should insert their current policy here. The board is responsible for establishing the procedure by which the student member is chosen. The policy or administrative procedures should describe the election or selection process and require that it be completed so that the student member is able to assume office by June 1, or May 15, whichever is applicable.**

**Note: The following is provided as language that will comply with the requirement of the Education Code that all students enrolled be permitted to participate in the selection of this student member. See, 62 Ops. California Attorney General 126 (1979).**

The student member shall be elected by all the students of the student body in a general election held for that purpose. Normally an election will be held in the Spring semester so that the office is filled by June 1.

Special elections shall be held if the office becomes vacant by reason of the resignation or disqualification of an elected student member, or by any other reasons. Special elections shall be held within thirty (30) days after notice of the vacancy comes to the attention of the [CEO].

Candidates for the position may nominate themselves or be nominated by others by the filing of an application certifying that the candidate is eligible for service under the criteria set forth in California law and these policies. The election will be conducted in accordance with administrative procedures established by the [CEO].

## BP 2435 Evaluation of President/Superintendent

Reference: **Accreditation Standard IV.B.1**

Board Approved: 04/13/05

The Board shall conduct an evaluation of the President/Superintendent at least annually. Such evaluation shall comply with any requirements set forth in the contract of employment with the President/Superintendent as well as this policy.

The Board shall evaluate the President/Superintendent using an evaluation process developed and jointly agreed to by the Board and the President/Superintendent.

The criteria for evaluation shall be based on board policy, the President/Superintendent job description, and performance goals and objectives developed in accordance with Board Policy 2430.

## BP 2435 Evaluation of [ CEO ]

Reference:

**Accreditation Standard IV.B.1**

The Board shall conduct an evaluation of [CEO] at least annually. Such evaluation shall comply with any requirements set forth in the contract of employment with the [CEO] as well as this policy.

The Board shall evaluate the [CEO] using an evaluation process developed and jointly agreed to by the Board and the [CEO].

The criteria for evaluation shall be based on board policy, the CEO job description, and performance goals and objectives developed in accordance with Board Policy 2430.
