



APPLICATION CHECKLIST

Once all of the items below have been received by Ohlone College your application is complete. If you are admissible you will then be provided an Acceptance Packet.

COMPLETE THESE ITEMS:

- International Student Application**
 - Spring Semester Application Deadline: October 31 Spring classes begin in late January
 - Summer ELI Term Application Deadline: April 30 Summer ELI classes begin in early June
 - Fall Semester Application Deadline: May 31 Fall classes begin in late August

Notes: 1. Transfer Applicants currently in America may apply later than these deadlines.
2. The ELI offers Mid-Semester start dates in Spring and Fall. Visit the ELI web site for details
- Financial Affidavit** You and your financial supporter(s) must complete and sign this form.

SUPPLY THESE ITEMS:

- Bank Statement** An official bank statement, from the student or student's financial sponsor, demonstrating a minimum U.S. (or equivalent) \$19,630 in funds available. \$24,681 is the requirement for English Language Institute applicants.
 - Proof of Graduation** from high school, college or university. Official transcripts may be used.
 - \$50.00 Application Fee** This fee is nonrefundable. It may be paid by credit card, using the Credit Card Payment Form. Or, it may be paid by check (bank draft), to "Ohlone College".
 - * TOEFL or IELTS Score Report**, indicating a minimum 57 score on the internet-Based TOEFL, 490 on the Paper-based TOEFL, or 5.5 Overall Band Score on the IELTS. An original score report is required. See www.ets.org/toefl and www.ielts.org The Ohlone College ETS code is 4579
 - * Students without the English proficiency required for Direct Admission may be Conditionally Admitted. Conditionally Admitted students first study in the Ohlone College English Language Institute (ELI). Visit <http://www.ohlone.edu/org/international/eli.html>
- For Transfer Applicants ONLY: If you currently hold an F-1 Visa and are in Visa status at another school in the U.S. you are considered a Transfer Applicant. In addition to all of the items above, please also include with your application the following 4 copies:
- (1) A copy of your **current Form I-20**; (2) a copy of your **passport Biographical Information page**; (3) a copy of your **Visa**; and (4) a copy of your **I-94 (front and back)**
 - Ohlone College will work with your current school to coordinate your transfer.

FINANCIAL AFFIDAVIT

International students are required to provide documentation of financial support before a Form I-20 can be issued to them by Ohlone College. Documentation of financial support includes 2 items: 1) this completed Financial Affidavit form; and 2) an official bank statement. **Please submit BOTH of these items as part of your application.**

SELF-SUPPORTING STUDENTS: If the student will use his/her own personal funds as the source of financial support, the student **must provide an official bank statement** showing the availability of at least \$19,630 in liquid assets, **and** complete the Statement of Financial Obligation below. ELI students must demonstrate \$24,681 in liquid assets.

STUDENTS SUPPORTED BY A FINANCIAL GUARANTOR: If someone else will financially support the student (examples: family member, friend, or private institution,) the Financial Guarantor **must provide their official bank statement** showing the availability of at least \$19,630 in liquid assets, **and** complete the Statement of Financial Obligation below. ELI students must demonstrate \$24,681 in liquid assets.

Bank statements and Financial Affidavits must be dated within the last 6 months

After Submitting your Application

- After submitting your application to Ohlone College, the International Programs and Services office will check it for completeness.
- You will be notified via e-mail or telephone if any items are missing.
- Once your application is complete and if you are deemed admissible, Ohlone College will issue you an Admission Letter, and a Form I-20. Transfer Applicants will receive a Transfer Letter instead of a Form I-20.

Note: Ohlone College alone determines the admissibility of international applicants, based upon their demonstrated fulfillment of international admission requirements. Said fulfillment of these requirements is also determined by Ohlone College alone.

- Those documents will be supplied to you in the manner you request in the application.
- New students not currently in America will use the Form I-20 to apply for their F-1 Student Visa at the U.S. Embassy or Consulate nearest to their home.
 - Transfer Applicants will show the Transfer Letter to their current school, and request a Transfer of their I-20 to Ohlone College.
