**OBJECTIVES OF THE COURSE:**              The student will:

Differentiate algebraic, trigonometric, logarithmic, exponential and inverse trigonometric functions.

Apply differentiation to problems in areas of geometry, physics, engineering and business.

Integrate algebraic, trigonometric, and exponential functions using substitution techniques.

**CLASSROOM INSTRUCTION, EXAMINATIONS & COURSE REQUIREMENTS:**

The grades for this course are based on the following items:

1. Attendance: You will receive one point for each class you attend by being on time and attending the whole class.
2. Homework: Your daily homework assignment is to work all the "every-other-odd" problems listed on the class schedule for that day. These homework assignments from each chapter are to be stapled together and turned in on the due dates listed on the Course Schedule. They must be done in pencil in your own handwriting. No Xerox copies will be accepted. Each of the 5 packets of homework assignments will receive a maximum of 5 points, as long as the assignments are complete and correct.
3. Weekly Quizzes: (Please see the back of the Course Schedule.)
4. Tests: There will be 3 one-hour exams each worth 100 points, the lowest of which will be dropped.
5. Required Comprehensive Final: 150 total points possible.

**GRADING POLICY & EVALUATION OF STUDENT PERFORMANCE:**

1. Assignments that are from 1-7 days late will receive HALF of the original points due even if you are absent on the original due date. Note: NO CREDIT for assignments that are over 7 days late. (Going out of town? Turn it in before you leave!)
2. If you are unable to be in class the day of one of the three regular in-class exams (due to illness, etc.), that is the grade which is AUTOMATICALLY dropped.              NO MAKE-UP TESTS!  
(Only exception: those having a written doctor's excuse)
