The application will be signed under penalty of perjury. Upon review and approval, a Carpool Parking Permit will be issued to the applicant(s) for the academic semester.

CITATIONS WILL NOT BE RECOMMENDED FOR DISMISSAL FOR A LOST OR FORGOTTEN PERMIT, IMPROPERLY DISPLAYED CARPOOL PERMIT, (MUST BE HUNG ON INSIDE REAR VIEW MIRROR AND/OR READABLE FROM OUTSIDE OF THE VEHICLE), NOT KNOWING THE REGULATIONS, NOT PROPERLY DISPLAYING A VALID SEMESTER OR DAILY PARKING PERMIT.

INITIALS Carpool Vehicle Parking permits are valid only for the driver(s) and vehicle(s) listed in the application.

INITIALS It is a violation of the law to copy, duplicate, manufacture, or otherwise reproduce Carpool Parking Permits. Violators are subject to arrest and prosecution for forgery and theft pursuant to California Penal Code sections 470 and 484.

INITIALS Carpool Parking Permits may not be transferred or lent to another person. Anyone displaying a Carpool Parking Permit not issued to them is subject to citation and seizure of the Carpool Parking Permit. A report will also be forwarded to the Vice-President of Student Services for a violation of the Student Code of Conduct. The seized Carpool Parking Permit will not be returned to the person(s) who applied for the permit.
