Bryan & Baxter (Bryan Bonner and Matthew Baxter) are the founders of the Rocky Mountain Paranormal Research Society, through which they investigate claims of the paranormal and occult. Their investigations of ghosts, poltergeists, psychics, UFOs, conspiracy theories and urban legends are both informational, educational and entertaining.

THEIR CAREERS

The Rocky Mountain Paranormal Society was founded in 1999, based not upon the personal experiences of paranormal events, but by an interest in the paranormal developed by horror movies (such as *The Exorcist*), and the paranormal claims made in ghost hunting reality television shows. Bryan & Baxter make the distinction that they do not investigate the paranormal, but rather the legitimacy of the paranormal claims made by others. Their credentials include manufacturer certifications with the equipment they use, certification in electromagnetic field studies for broadcast equipment, and a background in video production and photography. They also work with a network of people in other specialties, including geologists, physicians, video and audio production

specialists, psychologists, linguists, and magicians, the latter being of special value due to their expertise in misdirection.

PUBLIC OUTREACH

Bryan & Baxter give presentations and classes to the public dealing with pseudoscience and the paranormal. These events have included presentations at the University of Colorado, Metropolitan State University, The Denver Art Museum, Skepti-Camp, The Amazing Meeting, and StarFest/HorrorFest.

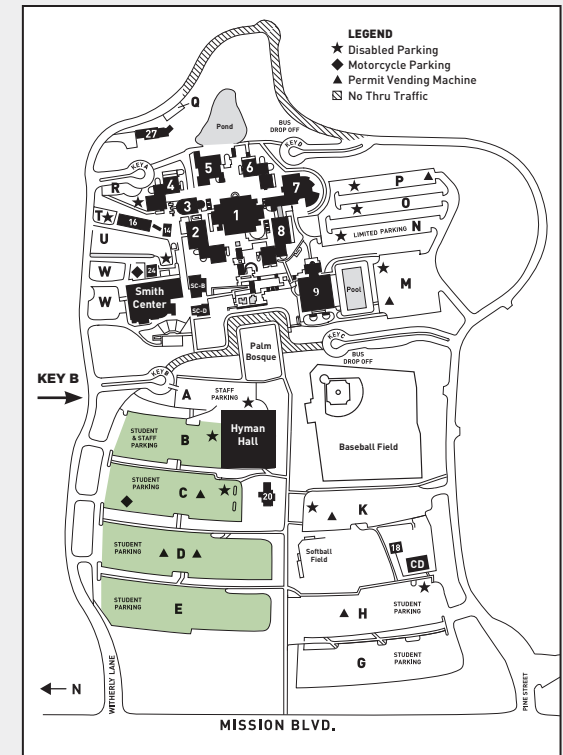
